

REPORT OF
STORMWATER MANAGEMENT SERVICE CHARGES FOR Fiscal Year 2026-2027
IN ACCORDANCE WITH CHAPTER 14.04.100 OF THE
SOUTH SAN FRANCISCO MUNICIPAL CODE

In accordance with Chapter 14.04.100 of the South San Francisco Municipal Code, staff submits the following report prepared as of April 22, 2026. This report describes the procedure for charging those parcels of real property, which receive benefits of stormwater system services, and the amount of the annual charge, which will be imposed against each parcel for Fiscal Year 2026-2027.

This report summarizes the Fiscal Year 2026-2027 charges that will be reviewed by the City Council on June 10, 2026. Upon adoption of the proposed charges, or amendments thereto, the report entitled “City of South San Francisco Stormwater System Charges,” prepared by Engineering Data Services, Los Altos, California, describes the amount of annual charge imposed against each parcel, by Assessor’s Parcel Number, for Fiscal Year 2026-2027. All of these documents, including this report, shall be filed with the County Tax Collector or Auditor. Accompanying the filing of this report shall be the City Clerk’s endorsement that the report has been duly adopted by the City Council.
