CALL TO ORDER

REMOTE PARTICIPATION UNDER AB 2449:

AB 2449 provides that a member may not participate in meetings solely by teleconference for more than three consecutive months or 20 percent of the regular meetings for the local agency within a calendar year due to "just cause" or "emergency circumstances."

Members participating through remote teleconferencing must use both audio and visual technology. Members must publicly disclose at the meeting before any action is taken whether any other individuals 18 years of age or older are present in the room at the remote location with the member and the general nature of the member's relationship with the individual.

Councilmember Nagales informed members of the City Council he would be attending the meeting remotely under AB 2449 due to an emergency that prevented him from attending the meeting in person. Councilmember Nagales stated no individuals 18 or older were in attendance.
