**What qualifies you for this position?**

I have lived in South San Francisco for more than twenty-five years and have many fond childhood memories thanks to the South City Park and Recreation department. My father taught me to swim at the Orange Memorial Pool and I learned to play tennis at the court in Brentwood Park. I have taken many classes offered through the SSF Park and Recreations Activity Guide over the years. In recent years, I can be found cycling though South City's parks and bike paths on weekends. In 1996, I became an Eagle Scout and my community project was to restore and landscape the area surrounding the Bocce Ball Courts in Orange Avenue Park. The project took several days to complete with about twenty volunteers.

For my final project, I restored an area surrounding the San Carlos Library, installed an irrigation system and planted drought resistant, pollinator-friendly and native plants. In an ongoing agreement with between the UC Master Gardner Program and the City of San Carlos, the city will provide ongoing financial support for necessary plants and supplies and Master Gardeners will volunteer their time to maintain the area. It is my hope that this partnership will serve as a model between the UC Master Gardner program and other cities, including South San Francisco.
