#### **CALL TO ORDER**

Mayor Flores called the meeting to order at 6:30 p.m.

#### **ROLL CALL**

#### PLEDGE OF ALLEGIANCE

Community Emergency Response Team Member Sonny Koya led the pledge.

#### AGENDA REVIEW

City Manager Ranals noted Administrative Item No. 15 would be postponed to a future date.

Executive Assistant to the City Manager Patea informed the public of the following events:

Assistant City Manager Lee introduced interim Finance Director Drew Corbett. Finance Director Corbett expressed his gratitude for the opportunity to serve the City of South San Francisco.

Parks and Recreation Director Mediati invited the community to attend the annual Concert in the Park on Saturday, September 20, 2025, 11:30-5:00 p.m. at Orange Memorial Park.

City Manager Ranals provided clarification about city staff who participated as members of the city's delegation trip to Sister City Kishiwada, Japan, and provided an overview of city resources used, noting that a future policy on staff participation would be brought forward during the City Council Handbook review.

#### **PRESENTATIONS**

1. Proclamation celebrating National Hispanic Heritage Month. (Eddie Flores, Mayor)

Mayor Flores proclaimed September as National Heritage Month and presented the proclamation to San Mateo County Poet Laureate Antionio de Jesus Lopez. Poet Laureate Lopez expressed his gratitude for the proclamation and shared his poem; *County Be Thy Name*.

2. Proclamation recognizing September as Prostate Cancer Awareness Month. (Eddie Flores, Mayor)

Councilmember Nagales proclaimed September as Prostate Cancer Awareness Month, read the proclamation into the record and presented it to Dr. Barry Chauser of Seton Medical Center. Dr. Chauser highlighted the importance of screenings and expressed his gratitude to the Council for the recognition.

3. Proclamation recognizing September as National Preparedness Month. (Eddie Flores, Mayor)

Mayor Flores recognized the contribution of the City's Community Emergency Response Team (CERT) members and invited each member to introduce themselves by name and length of service. Following the introductions, Mayor Flores presented the proclamation to Fire Chief Samson, who thanked the Council.

4. Proclamation recognizing September 17 – 23, 2025 as Constitution Week. (Eddie Flores, Mayor)

Councilmember Coleman proclaimed September 17-23, 2025, as Constitution Week and presented the proclamation to former elected City Clerk Sylvia Payne. Former City Clerk Payne informed the community of Daughters of the American Revolution (DAR) and noted the exhibit is available in the Library.

#### **COUNCIL COMMENTS/REQUESTS**

Councilmember Nicolas highlighted the Tree Lighting Ceremony in remembrance of Childhood Cancer Awareness Month and Juliana Peña. She shared the weekend she spent in Delano to commemorate the 60<sup>th</sup> anniversary of the Delano Grape Srike. Lastly, she requested the meeting be adjourned in memory of Asian American Recovery Services Project Supervisor Nani Wilson and Father Eric Velandrea.

Councilmember Coleman reported attending the Organization of Chinese Americans banquet and congratulated South San Francisco resident Dr. Randall Yip on being honored at the event. He also issued a statement condemning political violence.

Councilmember Nagales reported attending back-to-school night events speed limits were acknowledged with enthusiasm. He also reported he attended the tree lighting event in memory of Juliana Peña. Lastly, he noted the San Mateo County Board of Supervisors approved a resolution establishing a project labor agreement and expressed interest in exploring a similar agreement for the City.

Vice Mayor Addiego stated he had no report but acknowledged Councilmember Coleman's comments regarding the history of political violence.

Mayor Flores requested that the meeting be adjourned in memory of former Cupertino Mayor and League of California Cities Peninsula Division Treasurer and Secretary Hung Wei, as well as Jose Acosta Ahumada, father-in-law of City Clerk Govea Acosta. He also expressed support for considering a project labor agreement and joined in condemning political violence.

Mayor Flores requested that City Manager Ranals provide clarification on street maintenance responsibilities as they pertain to the City, SamTrans, and property owners. He further recommended that Code Enforcement staff provide a presentation at a future meeting to inform the public of the city's responsibilities. At the request of Councilmember Addiego, Assistant City Manager Lee provided an update and reported that BCDC maintains authority over the Bay Trail.

- 11. Report regarding Resolution No. 132-2025 approving Budget Amendment Number 26.019 and authorizing the City's acquisition of a Below Market Rate (BMR) unit at 2230 Gellert Boulevard, Unit 3303 (APN 104-540-230). (Elia Moreno, Management Analyst I)
- 12. Report regarding a second reading and adoption of Ordinance No. 1675-2025 adopting a Development Agreement to extend approved entitlements to construct a new Office/R&D Campus and multi-family residential building at 180 El Camino Real in the Planned Development (PD) Zoning District for a period of ten (10) years in exchange for payment of Community Benefit Monetary Contribution obligations in accordance with Title 19 and 20 of the South San Francisco Municipal Code. - 13.
