CALL TO ORDER

ANNOUNCEMENTS FROM STAFF

1. Presentation from LifeMoves (Marlon Mendieta, LifeMoves)

Guest presenter Marlon Mendieta from LifeMoves provided an overview of the organization's homeless outreach teams, which serve multiple regions, including South San Francisco. The presentation highlighted team successes, points of contact, current services, and a new program initiative.

Devin Stenhouse, DEI Officer, noted that South San Francisco previously had a dedicated case manager and emphasized the importance of restoring representation specific to the City.

Following the presentation, commissioners had the opportunity to ask questions. Commissioners inquired about further program details and public informational efforts focused on reducing stigma through language.

The commission discussed survey questions and wording. They also talked about tabling and what it might look like. The commission came up with a list of questions to get feedback on how residents feel about safety and trust at the local city level.

The Commission discussed the purpose of the annual retreat and identified priorities for discussion, which included:

- Review of bylaws
- Review of Commission goals
- Increasing visibility of the Commission
- Reflecting on Commission accomplishments
- Narrowing down recommendations for City Council
- Reviewing the Racial and Social Action Plan
- Reviewing the City's General Plan
- Considering how other commissions operate
- Potentially developing an equity guide for other commissions and boards
- Reviewing results of interviews and Placer.ai data

ITEMS FROM BOARD MEMBERS, COMMISSIONERS, COMMITTEE MEMBERS

Vice Chair Sanders stated that community groups involved in opposition to a local expansion project would be invited to present to the Commission.

Devin Stenhouse asked follow-up questions of Vice Chair Sanders regarding potential group presentations, including which groups would be involved, what issues they are advocating for, and how such presentations would benefit the Commission.

Additionally, Commissioner Harrison was informed about a community survey that may have been distributed to South San Francisco residents. Devin Stenhouse noted that an official City survey would typically include the City's stamp or branding, and recommended verification before circulation.

Devin Stenhouse also informed the Commission about the National Night Out event, its purpose, and encouraged commissioners to attend and participate.
