#### 5. Motion to approve meeting minutes from the June 17, 2025, meeting.

#### 6. Fiscal Year 2025-26 Co-Sponsorship Renewals:

Management Analyst Jung shares that staff has review and determined that the San Mateo County Athletic Club is eligible for renewal. She introduces Brian Mansell and Patty Gomez to share information about the club and answer questions the Commission may have.

Commissioners, Brain Mansell, Patty Gomez and staff engage in questions and discussion. Motion to approve co-sponsorship agreement renewal for fiscal year 2025-26 for the San Mateo County Athletic Club.

# **ITEMS FROM THE COMMISSION**

Commissioner Lock shares that the dog park looks great and dog owners seem to love all the new features. He also thanks Manager Richardson and crew for taking care of a tree on the corner of Grand Ave.

Commissioner Rey shares that Movie in the Park was great and if staff need help in the future to let her know. She asked if there was a technical issue with the projector to which Manager Armanino responded that the movie was originally cast via DVD and there was a technical issue with the player. They also had a digital copy, so they were able to cast through her laptop to get the movie back on. Commissioner Rey then shares that her dog has also played on the new features at the dog park and a lot of people are utilizing the area. She suggests adding more agility features at the Oyster Point Dog Park.

Vice Chair Camacho suggests that since Genentech sponsored the new additions to the dog park, if they help do Oyster Point Dog Park next year, it may be a good idea to tie it in with a dog event. Commissioner Camacho shares that she liked reading about staff's wood milling and reuse and would love to see a demo sometime.

Commissioner Uy thinks Oyster Point would be the best location for a dog event if we were to have one. He then shares that the tennis court at Alta Loma Park is really bad and there are weeds growing in the cracks on the court. Director Mediati responded that they are aware of that court, and it is on the list for repair. Commissioner has noticed that there is good usage of pickleball at Buri Buri and Sellick Parks but suggests buying heavy duty nets when the current ones need to be replaced and possibly resurface the court at Sellick Park.

Commissioner DeNardi suggests possibly collaborating with Wag Hotel for any dog events considered. She shares that community members have suggested having tribute bands in the parks to play like some of the other cities are doing. Deputy Director Duldulao shares that they've been looking at bringing more entertainment to the Farmers Market and that there was a survey that went out on this topic. Commissioner DeNardi asks if the work on the bocce facility will happen beginning September 15. Director Mediati responded yes. Commissioner DeNardi then thanks Manager Richardson and team for tree maintenance and bird dropping cleanup at Centennial Way Park South. She then asks if the Farmers Market will continue next year. Director Mediati responds that the City Manager's Office is looking at alternative locations. Commissioner DeNardi shares that they Parks and Recreation Bocce Program is up to 150 participants.

Vice Chair Camacho asks if staff need volunteers to help at movie night this Friday, to which Manager Armanino responded that if any of the Commissioners want to come to help there will always be something to do. Vice Chair Camacho shares that the IPP Committee will host a park cleanup at Orange Park on September 9 and 17 during the day in case any of the Commissioners are interested in volunteering. Vice Chair Camacho also makes more suggestions on dog events and programs.

Chair Burgo shares that she attended movie night and enjoyed it. She asks how the movie this Friday will be showing after the technical difficulties they had at the last one. Manager Armanino responds that they will probably go with the DVD that evening, but if there are any issues they will have backup plans with laptops available.

# **ITEMS FROM STAFF**

Joshua Richardson shares that a contractor will be starting to install new lighting at Terrabay parking lot next week. He then shared that even though volunteers helped install the dog park features, staff custom built those features and would like to thank staff for their work.

Being no further business, Chair Burgo adjourned the Parks and Recreation Commission meeting at 9:04 p.m. in honor of Sensei Sue Miller.
