## ITEMS FROM THE COMMISSION

Commissioner DeNardi shares that she attended Halloween Extravaganza and enjoyed the event, including the pumpkin patch and storybook walk. Commissioner DeNardi was only able to stay for a little amount of time but was curious to know how the rest of the day went. Manager Armanino responded that it was busy pretty much all day with all age groups.

Commissioner Lock thanks staff for creating the reservation system for Santa Comes to Town.

Commissioner Uy thanks Director Mediati and staff on the efforts to construct pickleball courts.

Vice Chair Camacho shares that she attended Halloween Extravaganza and had a good time. She felt that having the pet costume contests helped bring in a different crowd because some of the people that came only had dogs and no kids. Vice Chair Camacho asked if they had a lot of leftover pumpkins after the event. Manager Armanino replied that they only had about 17 left from the pumpkin patch. The pool had some left over too, but they use their leftovers during swim lessons. Vice Chair Camacho suggests if possible, reducing the cost of the pumpkins a little because in the area generally you can get large pumpkins for \$5-\$6. Vice Chair Camacho then shares that she thought the pop-up event at Linden and Pine to show the mural options was well done. Manager O'Brien shares that the survey is online to solicit input. She shares that the sub-committee of the Cultural Arts Commission will meet in advance of their November 25 meeting to provide a recommendation that will be presented to the full commission at the November 25<sup>th</sup> meeting. They are hoping for a quick turnaround for the

December 10 City Council meeting. Vice Chair Camacho then shares that she received a request for a movie night to show K-Pop Demon Hunters.

Chair Burgo shares that she also attended the Linden Park pop-up and though it was well organized, and it was nice to speak with the artists. She was able to speak with residents that have used the Throne restroom at the park and provided feedback. The concept is good, but she would prefer the typical restroom option.

Vice Chair Camacho shares that she ran into someone from San Bruno Mountain Watch over the weekend and was given a copy of an article about a data center that is being proposed on San Bruno Mountain. Director Mediati responds that the project is within the former quarry, and outside the City's jurisdiction.

Chair Burgo shares that today will be her last meeting as she has accepted a new position with the City as a Recreation and Community Services Coordinator. She enjoyed being a part of the Commission.

Commissioners thank and congratulate Chair Burgo.
