Assembly Bill 481

- September 30, 2021 – Governor Newsom signed several police reform bills, including AB 481
- Increase transparency, accountability, oversight for acquisition and use of defined equipment
- Provide safeguards to protect public's welfare, safety, civil rights, and liberties
