2. Commissioners will discuss the results of the FlashVote survey that was distributed to registered participants in South San Francisco from June 12 through June 14, 2025. (Devin Stenhouse, DEI Officer)

DEI Officer Stenhouse presented the FlashVote survey results from South San Francisco. Commissioners discussed overall trust in city leadership, with 67% of respondents expressing some level of trust. They also reviewed community safety perceptions, with 52% of respondents reporting they feel generally safe. Commissioners noted the low number of respondents per district and discussed using additional demographic data from Placer.ai to provide context

3. Commissioners will generate questions to ask guests at the Cultura Fest event on August 23, 2025, in South San Francisco and determine the method in which the questions will be asked. (Devin Stenhouse, DEI Officer)

Commissioners discussed creating survey questions for attendees at Cultura Fest on August 23, 2025. DEI Officer Devin Stenhouse proposed questions about residency, district, trust in city leadership, and sense of belonging, with most being multiple-choice. He asked for confirmation that these are the types of questions the group wants to use. Staff was directed to assist with question development and formatting. Questions will be heavily based on the FlashVote survey questions, but formatted to be more in-person friendly.
