for their work on the immense task that was drafting the General Plan and the Housing Element. I am happy the City is moving in the right direction in a number of ways. Underscoring this historic nature is the fact that the 118th US Congress will conduct unprecedented investigations into the biggest crime ever committed against humanity by the biotech and pharmaceutical industries that has resulted in the epidemic of people who are dying suddenly from mass murder and the genocide that has been perpetrated and committed against the world's population.

Additionally, it is unbecoming and shows a lack of <u>moral core</u> to turn a blind eye to your constituents' needs.

SSF's Housing Element of 2023-2031 earmarks the MSB site **by default** for demolition. No, the intent to demolish it isn't SPECIFICALLY SPELLED OUT IN BLACK AND WHITE because the overall plan is to pave a path for political ambitions, to benefit big donors and deprive SSF seniors and residents of what is long overdue: A robust and thriving SENIOR CIVIC HISTORICAL & CULTURAL ARTS BUILDING, at 33 Arroyo Drive, in SSF, on the <u>west</u> side.

To these ends, I'll go back to my <u>original question</u>: What studies, what independent expert analysis reports and historical preservation criteria have you considered in ruling out the historical significance of the South San Francisco Municipal Services Building (MSB) in moving to slate it for demolition?

I live on the opposite side of our City. it was very disappointing to drive there, try to find any place to park in surrounding neighborhood as lot was filled, especially during street cleaning on Tuesday, to be told class was full.

After much frustration by many, it became necessary to restrict class size and participants can only attend one class per week.

Over the years, many activities once offered at this center have disappeared. The main focus seems to be to the infirmed and Adult Daycare population, which is definitely needed. However, the aging population of South San Francisco is growing, and as a taxpayer and homeowner, I strongly feel we deserve to have both an adequate facility and additional activities to enjoy in our senior years. It has been documented that keeping active benefits older adults. Many our of seniors have now taken advantage of the many activities offered by the city of San Bruno, though a greater number cannot do so due to restrictions such as driving etc. This is a sad fact that South San Francisco public servants seem to ignore, while declaring to be such a forward thinking city.

The preservation of the Municipal Services Building to a senior center will assure the needs of a larger number of our residents. The location is served by both public transportation and the City's free shuttle for those unable to drive. I urge you to postpone the decision concerning the Municipal Services Building and ask that it be removed from the housing packet you are considering at the Planning Commission meeting this Thursday, January 19th.

As our aging population (55 years and older) is growing, one senior center located in one part of the City, which caters to, with few exceptions, the infirm, and functions as an Adult Daycare facility is inadequate and does not meet the needs of the South San Francisco senior residents.

We need a dedicated senior center for our aging and active seniors. In the 2021 census, the population of South San Francisco was 66,331 with 24 percent aged 60 and older. The Municipal Services Building can be combined with the South San Francisco Historical Society, the South San Francisco Cultural Arts Commission, and other activities for our seniors and our youth that is a place to enjoy for everyone.

Most of our city is built out with development on top of development. We have two libraries, Grand Avenue and the new Campus, (Orange is slated for childcare), and we have one senior center on Magnolia. We need another senior center in this part of the city for our aging community.

I requested under the Public Records Act on 12/8/22 every and all records pertaining to the Municipal Services Building. To date, I have received a few, and the clerk has given herself two extensions so far.

#### Hello,

I want to provide support for retaining the Municipal Service Bldg. as a senior center or multi-use facility. I am a homeowner in Buri Buri, have lived here for 34 years and am now in my 80s. When I retired in 2000 from my job in San Francisco I had opportunities to use more of the services and businesses available in SSF. My dentist was here, my hair salon, gas station, grocery store. Doctors were outside of SSF. I always went to shopping malls further down the Peninsula and except for occasional fast food never visited any restaurants in SSF. Parking and access were generally the obstacles to going to a downtown restaurant. I liked the convenience of the MSB because there was good parking and I felt safe. It was a place to drop off expired medications in the lobby. I took some classes, attended some City Council meetings, and participated in a Citizens' Police Academy at that location. I especially appreciated the underbuilding parking because I became mobility impaired and knew the police and other help were close by.

I have never been to the downtown City Hall or library because they appear to present difficulty for me. I attended a Mature Driving Class presented by the CHP at the downtown senior center. I had difficulty parking and found moving around in that facility was difficult with a walker. I would probably never return to any event there. Given the significant population of seniors in SSF I believe having the MSB available for seniors would be helpful. At this point it is unknown how the new Civic Center will work for seniors and persons with disabilities. Retaining the downtown senior center seems practical too since I understand it to be an adult day care, Meals on Wheels lunches and bingo.

I have found the new Police Station to be difficult. I made 5 attempts to drop off an unused cell phone for their Domestic Violence Program, and there was never a parking place. The construction workers were using all the spaces on both sides of Antoinette Lane. I called someone in a City office to request that designated parking with time limits be provided at the Police Station, similar to what was at the MSB when the Police Station was there.

The pandemic years have demonstrated to many seniors how really isolated we are when there is no safe place to go. I hope MSB will remain available for seniors and that additional classes and activities designed for seniors will be added to this location.

Now, while I know the plan to retain the MSB building for community benefit conflicts with the plans to build the first 150 unit phase of SSF's version of Daly City's Geneva Towers and potentially a future 1000 unit project in a cooperative with Pacific Market, I'm guessing that it was spearheaded by our departed city manager who, curiously, only mentioned it once publicly at a CC meeting. I wonder why? That being the case, even though a massive low income housing project would be a feather in our Mr. Coleman's ambitious cap, it may not be the residents' "cup of tea." In the end, after creating what many residents feel are many messes in our city, with the CM's departure we can address the will of the residents, not just the will of a handful of city officials. After leaving us for the promise of Riverside, CA. after his nine year reign, the messes left behind are kinda' like when I walk my dog, the only difference being, I clean up after my dog.

So in closing, count me as another long term city resident who advocates the re-purposing of the old MSB for a senior/cultural arts center. Call me selfish but my advocacy is based on my investment in the soul and history of the city I call home. That's me, what are your motives? Cory A. David
