Mayor Nichols and Council members:

The Municipal Services Building (The MSB) is listed as a possible high density/low-income housing development site. It is up to code, has passed every inspection and is ADA compliant contrary to what we have been told. I have all the inspection reports through the FOIA/Public Records request I made on 12/8/22, and am awaiting the rest of the FOIA/Public Records request as the clerk has given herself two extensions, and was to give me an update as of January 17th -- I am still waiting and contacted her again.

However, Former City Manager Mike Futrell told me when I asked why all the developments in 2019, "They've been approved, and I'm implementing them!" If we have another city manager who cares more about his political aspirations than the good residents of South San Francisco, then we will again be facing this situation.

You haphazardly pick and choose what will be developed, remodeled and where -- the Grand Avenue Library, the Orange Library, the Arroyo Fire Station three times, and yet when asked why not development on Noor, the old Century Theatre, Futrell answered, "We cannot build anything there, it is in an airport flight path," but it is slated for development now. My, how things change when this City and City Council want something to happen.

The MSB is ADA compliant, has adequate parking, and the city, our residents, own this building with no financial incumbrances. It has a new roof, a new air quality system, the Fire Department has been remodeled three times at taxpayer expense, and it is a place of historical significance to all South San Francisco residents. If it were so dangerous to have been in use, then all activities, meetings, rentals, offices and classes would have been relocated to other buildings saving our city from liability.

We need a senior center on this side of the city. The biotech was relegated and isolated on the east side, and now we have it soon to occupy the Spruce development.

If you want to pander to the biotech for your future political climb to a county or state office, do it with your shining personalities and not on the backs of the good residents of our city.

Mayor Nicolas, you have been replying to residents telling them the cost of maintenance for the MSB will be high as its an aging building. Of course it's an aging building, that's what a historical building is, with significance for all South San Francisco residents. Vice Mayor Nagales proudly announced we have \$21 million in "east of 101 impact fees" and he directed the acting city manager to make it a priority to implement bike and walking trails for the biotech and corporations on the east side.

What about us?

We want the ENTIRE \$21 million "east of 101 impact fees" for the maintenance and future needs of the MSB. Who has been more impacted by the biotech and corporations than the good residents of South City?

Therefore, I respectfully urge you to put the residents of South San Francisco before your own political ambitions, remove the MSB from the 700-page housing element, and SAVE THE MSB!
