City Council,

I am writing you this letter to address this emerging false rhetoric that our city's police department is not like Oakland's or San Francisco's. I am writing to remind you that the protections that officers in SSF are granted are the same of those in our neighboring cities. The distrust that people have towards SSFPD is high and it is time that you no longer ignore the real and other narrative of what officers do. The truth is that officers are put in a situation in which they are allowed to act with lethal force. They are tasked to issue citations, respond to mental health crises that they are not equipped to handle, and make reports on poverty related crimes like theft that they will never likely solve. To be blunt, they are inefficient and, in many ways, counter to public health and safety. The truth is that the safest neighborhoods rarely have police patrolling or frisking their citizens. The truth is that these neighborhoods have a wealth of resources for mental, physical, communal health. They have opportunities because having money allows people to have those opportunities. This is what all the neighborhoods in SSF deserve. They don't need officers instilling fear with their weapons and citations. They need opportunities and support. Contrary to what some might think, people who are poor are not mostly thugs or gang members, most of them are hardworking people, a good number of which are essential workers. These are the people that are struggling to make money. These are the people that are affected by the pandemic only to have the city council fund a police budget that would enable officers to evict these people out from their homes when the moratorium on evictions is no longer in place. This budget will, in turn, support the continued criminalization of homelessness by upholding laws in which officers can cite homeless people. This solves nothing and only adds to the problem. We need to examine the real role of SSFPD and how we can really better help the most vulnerable people in SSF.

The United States imprisons 698 people per 100,000 people. The United Kingdom comes in at a distant second with 139 people per 100,000 people. It is undeniable that we have a problem. A significant number of inmates are given little to no resources to rehabilitate or fix the behaviors of their inmates. In fact, it is often argued that prisons make a person worse. With a recidivism rate of 76% and the fact that suicide is the second leading cause of death in prisons is an indication that when you treat people like animals, they, in turn will behave like animals. Dear Mayor Garbarino and South San Francisco City Council,

My name is Amanda Vergel de Dios and I am a resident of South San Francisco, mental health worker, and mother. I respectfully provide an expansion of my comments from the June 10th Public Comment regarding the budget proposal before you.

I am writing to advocate that our tax-payer money NOT go to increasing funds for SSFPD, but instead go towards increasing funds for community and mental health services and programs.

My experiences serving San Mateo County residents, including South San Francisco residents, in their mental health is largely a reason why I am supporting the divesting from SSFPD and investing in the needs of our community.

For the last two years, I have worked at the ONLY psychiatric crisis diversion program in San Mateo County called Serenity House. It houses 13 people at most for a short term stay. People voluntarily come to us when they feel that their mental health is deteriorating so that they don't hurt themselves or others. It is a diversion program so that people do not burden the emergency rooms. Serenity House has been providing clients with tools and resources so that they feel safe going back into the community.

Serenity House has helped a lot of people, and many of the clients have found value in the program. Many of the clients have experienced human realities and real life problems that shake the depths of your heart and radiate up through your tear ducts. They are hard working people like you or me. Mental illness does not discriminate.

Police have brought people in crises to Serenity House and I have seen police officers struggle with where to bring people most of the time because there are SO LITTLE RESOURCES for what is actually going on in the streets, which is homelessness because of the massive wealth inequality and drug and alcohol addiction due to underlying mental health problems because of severe childhood traumatic experiences.

If there were more programs like Serenity House in South San Francisco, it could actually help police too. There would be more resources for police officers to bring people to.

I am calling on our city council to commit to reducing the police budget and reinvesting in other essential programs such as COVID relief, affordable housing, educational enrichment, transportation, and community programs. Specifically, I would rather see funds go towards mental health programs, crisis de-escalators, and the Community Development Block Grant fund which serves to assist low income persons by: providing decent and affordable housing, providing a suitable living environment, and expanding economic opportunities.

The current funds dedicated to the SSFPD have been harmful to our community and I ask that our leadership take a look at alternatives to policing and in the meantime allocate money to programs and services that will benefit our community.

Thank you for your attention to my concerns. I hope to see action from our leadership soon.

The proposed budget reduction totals \$807,183. This still represents an increase compared to last year's budget. This is a half-hearted attempt to reduce the police budget in this manner as a means to placate the voices who have begun to speak up in South San Francisco.

There has been money set aside for new FTE to replace retiring police officers. This would have been the perfect moment to show a willingness to prioritize other departments over the police department. Instead, you've decided to continue to put our money where your priorities are.

As a resident of South San Francisco for most of my 32 years of life, I have always felt like SSF cared about the children that grow up within the community. The budget for Parks and Recreation will need to grow in order to better accommodate families with child care needs in the future as well. Money is being taken from Childcare Impact fees and being allocated to pay for a necessary portable at Ponderosa Middle School. 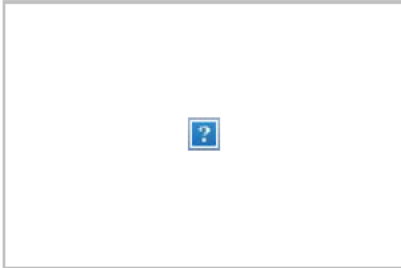

We are a public agency whose mission is to reduce the number of drive alone vehicles traveling to, from or through San Mateo County. Our goal is to help residents and commuters find alternatives to driving alone that are less stressful, less costly and better the environment. The agency provides information and commute planning assistance to employees, employer programs, and city transportation demand management partnerships.

Our work is urgent and utterly vital for the future of the planet. But it's leagues more challenging when support for alternative modes of transportation is lacking in the public sector. It's imperative that we put more resources into our public transportation, infrastructure for bicycling, and the general walkability of our city. And many of these types of projects are magnitudes cheaper than building and repairing roads for cars.

This is just one of the many, many sectors of our community that could benefit from redirection of funds from our police department. If alternatives to driving were better, more people would choose those modes more often. Not only would this improve air quality, improve health and well-being, and decrease carbon emissions, but it would also decrease the need for police because so much of our police activity is directed toward policing cars and drivers and policing parking.

City Council Members,

I am writing you to divest from SSFPD, as well as expand SSF's budget, in order to **invest** in the working-class families and people of South San Francisco. Such investments into our most directly impacted communities could provide services as well as develop talent and potential in a way that benefits our entire community.

In making this proposal, I encourage you to consider that safety, something we all value, is produced not through the presence of people armed with the right to use force, but, rather, investments in public well-being. For instance, **reduction in poverty can improve public safety**. A 2005 study by Lance Hannon and Robert DeFina, titled "Violent Crime in Africa American and White Neighborhoods: Is Poverty's Detrimental Effect Race Specific", found that decreases in poverty within segregated neighborhoods resulted in reductions in violent interpersonal harm. **The presence of community based resources is also associated with improved public safety**. Consider the 2017 study, led by NYU sociologist Patrick Sharkey, titled "Community and the Crime Decline: The Causal Effect of Local Nonprofits on Violent Crime", which found that, across 264 major cities, that an increase in organizations focusing on interpersonal harm and community life produce a declines in murder, violent crime, and property crime.

This proposal to divest from policing and into community could be a reimagining of public safety and well-being, which would position South San Francisco as a leading example. What might this look like?

This could entail **universal early childhood education** serviced highly trained professionals, which has life-long and community benefits. This would create jobs in our community, while all parents can work while their child is participating in curriculum that develops their social and cognitive abilities, which has far-fetched implications, as these children go farther in schools, earn more as workers, pay more in taxes, and are less likely to be entangled within the criminal justice system.

This would entail the presence of **ethnic studies curriculum for all our children in K-12 schools**, which would allow children to learn more about the contribution of their ethnic community to our society through resiliency, and for children to learn more about each other's cultures and histories, thereby serving as a unifying force in our community, even generative of cross-cultural events, music, arts, etc. Keep in mind that these programs have demonstrated improved academic performance for some of the most marginalized young people.

This could also look like the presence of **restorative justice programs and practices both in our schools and our communities**, which could help young people and adults alike work together to resolve existing conflicts in their community, all while developing interpersonal skills and cultures of conviviality, respect, and healing in our schools and street that can prevent future conflict.

This could look like **community centers with robust wraparound services** in our neighborhoods, which provide young people and adults with everything from group counseling, resources and support to reach their individual goals, to opportunities for personal enrichment in the arts, the outdoors, etc. This is the kind of resources that could practice a form of social alchemy, whereby some of our most marginalized, "at-risk" youth can become resources for themselves, their family, and community. This already exists in the form of the RYSE Center in Richmond, as well as Homeboy Industries in Los Angeles.

We can provide **paid internships for some of our most marginalized youth** as well, where a counselor learns their goals and interests, then pair them with a local organizations and/or business, where they can get hands on experience working in a particular profession, from healthcare for human bodies to mechanic shops for autobodies. This would anchor a young person into a community and into a career path, one that allows their horizons of possibility to expand.

In order to address interpersonal conflict, even harm, we can take epidemiological approaches developed by the

CureViolence strategy developed by Gary Slutkin, which understands violence not as a personal deficit (i.e. evil people), but through the lens of transmittable disease. Think about it this way, if you've been hurt by violence, you can be now "infected" by violence, and want to spread violence - either through revenge or self-defense. Cure Violence hires people from the community, themselves formerly involved in street organizations (AKA gangs), or even formerly incarcerated for acts of harm. These are people who are committed to improving the communities they once harmed, and who have rapport therein. They can take a proactive approach in "disrupting" the transmission of violence, by connecting with a person who survived an act of violent harm, help them process that trauma in a productive manner, and connect them to resources in order to do so.

In order to address homelessness, we can do a multitude of things, from unarmed civilian professionals tasked with connecting existing homeless people to housing through a **Housing First** strategy, **income supports** to prevent evictions and help people and their families stay housed, to **rent control** to keep SSF a city where working-class families can thrive, to the formation of **community land trusts** that produce affordable housing.

We can also develop a cadre of **unarmed civilian professionals tasked with connecting people with drug use and mental illness** to resources, ranging from **mental health clinics** to **supervised injection sites** (a strategy department proposed by the Law Enforcement Action Partnership, and practiced in Australia, Switzerland, Germany, and Canada, among other places, proven to reduce overdoses, public issues related to drug use, as well as connecting drug users to resources necessary kick their habits).

This also can look like the development of **worker cooperatives**, such as Arizmendi's in San Francisco, that provide working-class people with meaningful jobs that provide living wages, benefits, and leadership development experiences through direct democracy.

This is a profound moment of re-imagination, and I invite you to take the actions necessary to produce the world we all deserve.

Letter: Greetings,

I am emailing to demand that Mayor Garbarino, Vice Mayor Mark Addiego, and the City Council commit to divesting from the South San Francisco Police Department by reducing the police budget by 30%. I also demand that the city reinvests in essential programs such as COVID-19 relief, affordable housing, educational enrichment, public transportation, resources to address substance use disorder, and other community programs. The demonstrations across the nation have made it clear that there is a need for change. I refuse to be silent in the midst of injustice. The city of South San Francisco can and should be at the forefront of revolutionizing and reimagining our system of public safety.

Currently, the proposed budget for the next fiscal year would allocate \$31,935,228—28% of the proposed \$112,416,313 general fund—to the police department. I urge Mayor Garbarino and the city council to restructure the fiscal year 2020-2021 budget. The current investment in policing perpetuates a system that serves the purpose of controlling and threatening Black and Brown people. It is unacceptable that Black lives continue to be lost at the hands of police, and it is clear that policing reforms are not enough.

Specifically, I would rather see funds go towards mental health programs, crisis de-escalators, and the Community Development Block Grant fund which serves to assist low income persons by: providing decent and affordable housing, providing a suitable living environment, and expanding economic opportunities.

The current funds dedicated to the SSFPD have been harmful to our community and I ask that our leadership take a look at alternatives to

policing and in the meantime allocate money to programs and services that will benefit our community.

Thank you for your attention to my concerns. I hope to see action from our leadership soon.

My name is Edward Holman and I am a 3rd generation South San Franciscan. My family moved here in 1962 and bought a house in the Winston Manor neighborhood, something a working class family could still accomplish at that time. The year before, 1961, the city of SSF built El Camino High School, a brand new public school. This was a huge investment of our tax dollars into an institution to empower our middle and working class families with a quality education.

Unfortunately, today it seems that the leaders of our city have lost sight of what our priorities are as a community. Budget after budget has led to increases in the amount of money we spend on our police department. While at the same time, our teachers have to buy supplies for their own classrooms and can't even afford to live in the area. Year after year our public schools face brutal turnover as talented teachers leave the area because we don't pay them enough.

Today I call on you to have the courage to challenge your beliefs on the nature of policing in SSF. I'll be honest, until 2 weeks ago I considered "defunding the police" as an absurd idea. Dear City Council of South San Francisco,

I am writing because I am concerned with the lack of commitment from the SSF City Council in addressing the problems of institutional racism and police brutality. While many cities are implementing proactive policies designed to curb spending on police departments, you are set to approve Agenda Item 11, a budget that increases the SSFPD's funding. This is not what our community needs.

I am a teacher and resident in South San Francisco. As an educator, I work with students whose families cannot afford to pay rent and who have to help their families by working instead of focusing on their studies because we live in an area with limited affordable housing. I teach students who have shared a range of stories about their encounters with the SSFPD both on and off campus. These encounters are rarely positive, often racist and colorist in tone, and breed distrust between these students and the officers sworn to "protect" them. I teach students who deal with severe mental health challenges, but who cannot find counseling because our schools are underfunded.

My concerns with the city budget have skyrocketed after watching the Monday meeting that the City Council held in conjunction with Change South San Francisco. The police chief repeated multiple times that his department is not equipped to deal with mental health crises, or other social services. We agree as community members; these are jobs that require professionals who can help our community heal, instead of overpolicing it. The city's decision to back a budget that increases police funding when all evidence points to the importance of funding social programs concerns me.

I demand that you reallocate funds from the police department to support community-based services that are not tied to the police department. Implement a budget that is equitable for all citizens of SSF and that funds restorative programs. Only then will South City residents experience a higher quality of life.

Listen to your constituents' needs. Protect the most vulnerable among us by defunding the police in order to fund community-based programs, or we will vote you out.

I am writing to remind you that the protections that officers in SSF are granted are the same of those in our neighboring cities (SF and Oakland). The distrust that people have towards SSFPD is high and it is time that you no longer ignore the real and other narrative of what officers do. The police kill unnecessarily. The police use violence unnecessarily. The police police neighborhoods unnecessarily. The police only bring more tension and anxiety to communities. The programs, such as "coffee with a cop" or SRO's in highschools and the [copaganda](#) on the SSFPD facebook page, Everything South City, NextDoor, and during the City Council Roundtable all endorse the false narrative that the police are actually doing something. However, during the same roundtable, Police Chief acknowledged that the officers are not adequate to respond to mental health issues, he acknowledged that there needs to be more funding towards community programs and affordable housing, he acknowledged that the SROs in school do not do anything but "bring in more recruits".

While the 8 Can't Wait recommendations that the police department acknowledged and expresses general agreement with, what is left out of the conversation is accountability. We are asking that the city council take a closer look in addition to acting so that SSFPD can and will be held accountable when they engage in misconduct. Colorado recently signed a statewide bill that eliminated qualified immunity which for many years allowed officers who engaged in misconduct to not be held accountable in the court of law. At minimum, these officers would be put on administrative paid leave, only to return to active duty weeks later. Officers with records of misconduct are sometimes even hired in other cities, only to engage in further brutality. This lack of accountability and transparency has result in unjust killings and racial profiling. This is why people distrust the police. It is because many are silent in face of misconduct and that these bad cops are protected by the police union. No amount of sports programs and kneeling or hugging from officers will ever build trust with the community. Displaying that police corvette and handing out stickers will not bring someone's life back. Dear City Council,

I have reviewed the proposed budget for FY20-21, and want to express my disappointment with the city's lack of commitment in advancing racial equity and police reform. The **Police and the Council serve us** - the Black and Brown residents of South City. We are not a trivial minority; we are over 1/3 of the city's population. We have raised our concerns and offered solutions (e.g., re-allocate police funding to community services) that have thus far been ignored. Will the city take a stand, or continue to perpetuate systems of injustice through complicit lack of action?

D&I and police de-escalation training are concessions that we will not accept as enough. **Without accountability structures, training is all for naught.** Without sufficient investment into community resources such as education, healthcare, and housing, our communities are at-risk of destitution. Yet, the proposed FY20-21 budget significantly reduces funding for economic and community development, parks & rec, and public works, while minimally reducing the police budget.

According to a recent [NYTimes article](#), only ~4% of police officers' time is spent responding to violent crime. Why do we have ~85 armed officers allocated to policing the city if such a minimal amount of time is responding to violence? In their other time, officers are performing tasks that could be more effectively handled by trained specialists in mental health, de-escalation, and medical response. I will not pretend to have all the answers yet, but it would be advisable to, at minimum, engage community members in an investigation into our police department's use of time & resources, unnecessary use of force, and reported complaints **before finalizing this budget.** This analysis could uncover cost savings that could be re-allocated to **crime-preventing** community services (e.g., education, low-income resources, health), as well as bring to light specific, quantifiable areas of improvement in the department. **This is a necessary step in increasing accountability and trust, and the only way to make an informed decision on the FY20-21 budget.**

After being present online for the round table meeting, I witnessed how the city council neglects to listen to the people. I want to clearly state that what people are asking for is real change. While the 8 Can't Wait recommendations that the police department acknowledged and expresses general agreement with, what is left out of the conversation is accountability. We are asking that the city council take a closer look in addition to acting so that SSFPD can and will be held accountable when they engage in misconduct. Colorado recently signed a statewide bill that eliminated qualified immunity which for many years allowed officers who engaged in misconduct to not be held accountable in the court of law. At minimum, these officers would be put on administrative paid leave, only to return to active duty weeks later. Officers with records of misconduct are sometimes even hired in other cities, only to engage in further brutality. This lack of accountability and transparency has resulted in unjust killings and racial profiling. This is why people distrust the police. It is because many are silent in face of misconduct and that these bad cops are protected by the police union. No amount of sports programs and kneeling or hugging from officers will ever build trust with the community. Displaying that police corvette and handing out stickers will not bring someone's life back. It will not undo the years of loss from incarceration or the trauma of being searched and frisked in areas that people don't want to be touched. Deep down in your hearts, you know that what is happening is wrong. It is time to defund the police. It is time to take the power out of the police unions that protect bad cops and muzzle cops that want to speak out but fear for their own personal and professional safety.

Acknowledge Black Lives Matter. Respect the life of Derrick Gaines and say his name. Do not forget that he was a Black youth in our community. I was only a year younger than him and since then never felt safe when the police were around. The chief of police doesn't believe we should take funding from them yet the police department has the highest budget compared to parks and recs, healthcare, housing. Defunding the police doesn't mean letting officers go, it means to fund programs that are important to the people, create a community south san francisco needs for the future. Those corvettes will do NOTHING for the people of this city.

In America, Black adults are 5x more likely to be imprisoned than white adults. Latinx adults are imprisoned at 2x the rate of white adults. 1 in 18 Black women will be imprisoned at some point in their lifetime. For Black men, that number is 1 in 4.

Racism is not just something that floats around in the air, existing only in the metaphysical realm. It is a collection of public policies, government bodies, and budgets. It cannot be wished away, but it can be dismantled.

What message does it send to our Black and brown youth to be monitoring them constantly, telling them that we are just waiting for them to make a mistake? Random patrolling style policing has been shown over and over again to have no effect on overall crime rates. Not only that, I am still unlearning the way I have always felt undeserving in both higher education and corporate environments, because growing up, my community never invested in me. This cannot go on for another generation.

Stop pretending like you have no power to do anything about this.

Fire the SRO and use that money to hire a social worker and counselor to help our troubled teens. He should not be getting a six-figure salary to stand around and flirt with admin staff all day.

Fire the police that work in homeless outreach and use that money to hire people who are actually trained to work with the homeless.

Stop paying overtime to police for time spent in court. This literally incentivizes them to give out tickets unnecessarily. Use that money to make direct rental relief a permanent part of the budget.

Realize that just because police have historically been paid astronomical salaries, that it will not always be that way. Step up and make pay cuts. Use that money to provide our teachers with housing vouchers.

Deny the budget request for new guns and cars for the police. Do the old guns not kill people anymore? Use that money to keep the furloughed workers at the Magnolia Center on payroll. Stop funding GREAT when it has been proven empirically not to work. Fund a program that has actually been shown to help teens that are at-risk for gang membership.

If you say you care about racism and social inequities, you need to do something about it. Words are not enough, we need action. The purpose of a city government is to provide services to its people, not keep 83 police officers (68 of which do not even live in SSF) on payroll because that's what you've always done. Stop holding the hypothetical opinions of future transplants in higher regard than the opinions of people who have lived here their whole lives. It's really starting to feel like you don't care at all. I hope you prove me wrong.

Hello City Council of South San Francisco,

I am a resident of the City of South San Francisco and have been since my youth. I am writing with regard to recent calls nationwide to look at and reconsider how our nation's cities and states allocate our budgets toward the police department. As I am sure you are aware, many city officials around America (San Francisco, Minneapolis, Los Angeles, Seattle, etc) are committing to defunding their police departments. Much research has shown that policing does not actually improve the safety and wellbeing of residents across many different landscapes be it in suburban, urban and rural areas. What does, however, support the wellbeing and safety of community members in cities across the United States is deep trust and investment in our communities through housing, health care services, jobs, mental health services, and education (some of these I am fully aware are under county rather than city jurisdiction).

A great concern for me is how mental health is handled. I, like many other residents in this city, have mental illness in my family. I've witnessed how SSFPD have left an escalating mental illness situation saying that there is nothing they can do. If your son or daughter is considering suicide, the last thing you want to hear is police saying that they can't do anything and are leaving because others are not in danger. What about your child? Their life isn't worth saving by the people who are supposed to protect them? Having officers that are poorly trained in deescalation when responding to mental health calls has had considerably tragic outcomes. Data collected has shown that one in every four police killings is of a person with a mental illness. This means that people with mental illness are 16 times more likely to be killed by police than other people (The Treatment Advocacy Center). Having a mental health responder to treat the person with mental issues is most effective.

What is equally concerning is that I have seen little to no commitment from the City Council to address any of our concerns. The City Council has been quiet about Black Lives Matter as well. The City's Manager was not in attendance during the Black Lives Matter Peaceful March held on June 4th. We had concerns that needed to be addressed by the city. His presence would have demonstrated his commitment to our community. It truly disappoints me as a person who believes in our Council (we vote in) and the City Manager, that time and time again our concerns are not heard or taken into consideration.

In reading the budget for FY 19-20, I am appalled that \$31.9 million is being recommended in FY 20-21 towards funding the South San Francisco Police Department over extremely important community resources such as community development, housing, libraries, parks and recreation and community services. Year after year we see budget cuts taken from programs that keep our youth out of trouble but the police budget increases. Currently, SSFPD has a score card grade of D-. They have 16 civilian complaints of police misconduct. This is unacceptable. Until these matters are addressed, and their score is acceptable, they should not be receiving any increase in our city budget.

We demand that this city council ensure the safety of its people by committing to defunding the police and using such funds to create a team of first responders to address mental illness. We demand a budget that adequately and effectively meets the needs of at-risk South San Francisco residents during this trying and uncertain time, when livelihoods are on the line.

Not all of these cases are 'solved', and not all crimes are reported, so there provides an evident flaw in how policing in general 'protects' us.

Police are synonymous with safety in our society. What we are told throughout our upbringings, TV shows like Law and Order SVU, news stations, children's books, parents, and especially the police themselves, is that the police send 'bad guys' to jail where they think about what they have done and are rehabilitated. Is this really a solution? I demand that you muster the courage and empathy to begin reallocating funds from the police department to the people that have been suffering in this city.

Acknowledge how this will cause harm to the community. Do better.
