AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF SOUTH SAN FRANCISCO AND RAIMI + ASSOCIATES

THIS FIRST AMENDMENT TO THE CONSULTING SERVICES AGREEMENT is made at South San Francisco, California, as of July 31, 2020 by and between THE CITY OF SOUTH SAN FRANCISCO ("City"), a municipal corporation, and Raimi + Associates ("Contractor"), (sometimes referred together as the "Parties") who agree as follows:

RECITALS

A. On March 27, 2019, City and Contractor entered that certain Consulting Services Agreement ("Agreement") whereby Contractor agreed to prepare the General Plan Update, Zoning Code Update and Environmental Impact Report project, including an update to the Climate Action Plan, Form Based Code section of the Zoning Ordinance Update, and Downtown Storefront for public outreach plus a ten percent contingency. A true and correct copy of the Agreement and its exhibits is attached as <u>Exhibit A.</u>

B. City and Contractor now desire to amend the Agreement.

NOW, THEREFORE, for and in consideration of the promises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, City and Contractor hereby agree as follows:

- 1. All terms which are defined in the Agreement shall have the same meaning when used in this Amendment, unless specifically provided herein to the contrary.
- 2. Section 1: Term. The end date for the term of services identified in Section 1 of the Agreement remains unchanged.
- 3. Section 2: Compensation. Section 2 of the Agreement shall remain unchanged.

Contractor agrees this is the City's total contribution for payment of costs under the Agreement unless additional payments are authorized in accordance with the terms of the Agreement and said terms of payment are mutually agreed to by and between the parties in writing.

4. Scope of Services. The Scope of Services under the Agreement is amended by including the additional tasks set forth in <u>Exhibit B</u> to this amendment, attached hereto and incorporated herein.

All other terms, conditions and provisions in the Agreement remain in full force and effect. If there is a conflict between the terms of this Amendment and the Agreement, the terms of the Agreement will control unless specifically modified by this Amendment.
