Resolution accepting \$105,000 from the State of California, Office of Traffic Safety for the "Selective Traffic Enforcement Program" to be used for personnel overtime, equipment, and training expenses and to amend the Police Department's Operating Budget for Fiscal Year 2022-2023 by approving Budget Amendment 23.013.

WHEREAS, in January 2022, the Police Department submitted a grant application to the State of California Office of Traffic Safety (OTS) for funding of personnel overtime, equipment, and training expenses for the Selective Traffic Enforcement Program (STEP); and

WHEREAS, the grant application was reviewed and approved by OTS in July 2022 and the Police Department was awarded a grant for \$105,000; and

WHEREAS, the grant funding will be used to augment the operating budget of the Police Department for Fiscal Year 2022-23, including payment of personnel expenses and equipment purchase relating to traffic safety enforcement; and

WHEREAS, acceptance of this grant meets Strategic Goals #2 and #3 by rendering skilled police, fire and emergency service management and providing a high quality of life for residents; and

WHEREAS, staff recommends the acceptance of a grant in the amount of \$105,000 for personnel overtime, equipment, and training expenses from the State of California, Office of Traffic Safety (OTS) for the "Selective Traffic Enforcement Program".
